Administrator & Department Reports

Administrator Jonne Slemons told Council we are still awaiting engineering to fix the duckbill valve and UV chamber during the high water events. The grant money that was received from USDA has \$601,000.00 remaining and can be used for any costs associated with the design and retrofits and/or any supplies at the WWTP.

Lake Improvements Project Administrator Jonne Slemons told Council the final pay application is in the bills for approval to M & M Construction. The ADA slope requirements for the sidewalk to the fishing platform at the Old City Lake have now been met.

The application for the "Safe Route To School" has been submitted a few days early and the grant awards will be announced in February.

Tesla Charging Station

Administrator Jonne Slemons told Council the Tesla Charging Station project started construction on October 31, 2018. The switchgear is scheduled to arrive on Friday November 9, 2018.

Administrator Jonne Slemons submitted a bid for the Electric Department for R/S Electric to work on the riser poles that the city cannot access. The bids submitted were R/S Electric for \$5,975.00; Black and McDonald never responded.

2019 Budget

Administrator Jonne Slemons told Council that an error was discovered in the Budget that was enclosed in the packet. The new budget is available for each Councilman. Enclosed in the packet are worksheets for 5% and 10% decreases in electric and gas rates. Administrator Jonne Slemons asked the Council to go over the budget and advise her of any errors or concerns before or at the next Council meeting.

Customer Service Assistant Administrator Jacob Taylor advised Council he would like the City to start creating a long term strategic plan. All departments will start handing out comment cards to citizens that they have interactions with during their work day. The cards will ask for input on customer service, city services as well as future projects that the citizens would like to see in order to improve the City of Bethany.

Medical Policy

Nita Schroff, City Clerk, told Council a policy and procedure needs to be in place for customers that have health issues which require electricity. Nita Schroff, City Clerk explained there needs to be a policy in place so the staff at City Hall will be able to tell the consumer the procedures that he/she needs to followed on cutoff days. The Council approved the policy and procedure that was presented.

State Audit

Administrator Jonne Slemons told Council she will be sending the State Auditor a check for \$50,000.00 that was budgeted in 2018 and the remaining balance in January 2019.

Council Reports & Comments

Alderman Charles Crabtree talked with David Kinnison, Part-Time Fire Chief, about volunteer firefighters. Fire Chief David Kinnison stated he was informed there was a freeze on hiring and the Fire Department removed the sign for volunteers to sign up. Assist Administrator Jacob Taylor said that the physicals for the firefighters are not in the budget at this time but is included in the budget for 2019. Assistant Administrator Jacob Taylor explained the Police & Firefighter's need a different physical than the other department employees.

Alderman Randy Mann asked about the bowling alley property. Assistant Administrator Jacob Taylor told Council that Jacob Denum had talked with Randall Glenn and it is supposed to be completed by the end of November.

Mayor Correspondence & Appointments Mayor Todd Williams would like the Park & Recreation Department to reach out to a firm to get a plan for the new property improvements and put the funds in next year budget.

Mayor Todd Williams would like to tell everyone he felt Halloween was a success and the children who came to his house were very polite by saying please and thank-you. The kids' behavior was remarkable and the schools or parents are doing a wonderful job.

Mayor Todd Williams would like to appoint Katelyn Addison to the Park & Recreation Board.
