Public Input

Administrative & Department Reports

Assistant Administrator Jacob Taylor explained to Council they had approved for Electric Department to order supplies for 2019 Street Lighting Project if there were funds available after 2018 project.

Kenny Robertson, Electric Superintendent, explained to Council Kriz-Davis was bought out by Border States. Border States was using the Electric Department's incorrect email address so we were not getting the invoices to be paid. After receiving a current statement from Border States all invoices have been accounted for and bill is current. Until this issue is completely corrected, we are holding off on purchasing the 2019 Street Light materials.

Transformer

Kenny Robertson, Electric Superintendent, told Council the transformer that was placed at the Bethany Fair Cattle Barn was the old Immanuel Baptist Church transformer.

The City pays for all the overhead lines & poles. If a business requests underground service the City figures the cost both ways and the business pays the difference.

The City provided the church with a transformer and if they want to go to phase 3 they will have to purchase a new transformer. If anything goes wrong with the transformer the City pays for a new replacement. In the past the City charges the business half price for a used transformer. The Cost of the transformer would be \$6,641.00, Kenny Robertson, Electric Superintendent, recommends selling the 225 KVA transformers to the Bethany Fair for \$3,320.50.

Motion made by Alderman Charles Crabtree to approve Kenny Robertson, Electric Superintendent recommendation to sell transformer to Bethany Fair for \$3320.50 and seconded by Alderman Lance Johns.

Assistant Administrator Jacob Taylor would like to pass an Ordinance for transformer and tree removal policies for the City. Mayor Todd Williams would like to include that tree or shrubs should not be planted a certain distance from electrical lines. Assistant Administrator Jacob Taylor will talk to other cities to see if they have anything in place.

Street Paving 2018

The 2018 Street Paving is complete. Herzog will return to start backfilling along the streets when the weather is cooler.

The Planning & Zoning meeting is scheduled for October 8, 2018 in regards to closing certain streets.

Concrete Plant

Assistant Administrator Jacob Taylor contacted Tim Fischer to make him aware that he is responsible to get the survey or appraisal on the land by the asphalt plant. Tim understands and will notify the City when he has completed either one, so the City can go out for bids.

Bond Closing

USDA has requested the bond closing for the Waste Water Treatment Plant be added to the October 15, 2018 Council Meeting agenda.

Sealed Bids

Assistant Administrator Jacob Taylor told Council, a sealed bid auction of various equipment that is stored at the Power Plant located on the outer road is planned for September 20 & 21.

Lake Improvement Project Assistant Administrator Jacob Taylor told Council the final walk through with DNR and DEC is scheduled for September 25. Administrator Jonne Slemons would like to know if the City would like to have a grand opening at the lake for the new improvements. Mayor Todd Williams would like Assistant Administrator Jake Taylor to contact Missouri Department of Conservation and see if they are interested.

1804 Alder

Assistant Administrator Jacob Taylor has executed the transfer paperwork for the property at 1804 Alder. Closing is scheduled for October 22, 2018 and the \$10,000.00 from the seller will be sent after that date. Alderman Charles Crabtree asked Attorney Tara Walker if she had read the contact, which she hadn't. He was concerned if there was a well or any other costly concerns. Assistant Administrator Jacob Taylor will send contract to Attorney Tara Walker.

Drought

Assistant Administrator Jacob Taylor advised Council the water levels are up to normal levels at the Old City Lake.

Motion made by Alderman Charles Crabtree to rescind the drought order and seconded by Alderman Lance Johns.

Phone Bids

Assistant Administrator Jacob Taylor submitted bids for a new phone system. The bid includes 8 new phones, 1 conference phone, 4 wireless headset and installation with materials. The bids submitted were GRM Networks for \$6,480.31; and CSG, did not bid on items listed. Jacob Taylor recommendation is to go with GRM Networks since they were low bid and bid on everything for \$6,480.31. The budget amount was \$8,000.00.

Packet Delivery

Assistant Administrator Jacob Taylor expressed concern for when packets contain Closed Session information.

Water Main Replacement The contractor Rodriguez has started on replacing the water main on 16th Street. Rodriguez should be completed on 16th Street in a couple of weeks. Then they will continue to 25th Street, and install water main on 30th Street.

Oakland & Vandivert Properties

Harrison County Commissioners informed the City they would accept any offer on those two properties as long as the offer covers the advertising of properties and pays one year of property taxes. These two properties were

listed on the demolition list. The estimated cost for both properties would be \$529.65. Mayor Todd Williams would like a copy of the legal description to see the size of each lot.

Train Depot

Assistant Administrator Jacob Taylor told Council the Depot has been added to Missouri Preservation's list of "Places in Peril". This non-profit organization spreads awareness for organizations that have buildings that are in need of repair. They will work with us in the future to help save the building if we choose.

Bartlett & 14th Street

Assistant Administrator Jacob Taylor told Council the tubes are installed on 14th Street and Bartlett Street. The Street Department still has a lot of finishing work and needs to install some rip rap along the edge of the creek.

Improvements to City Hall

Assistant Administrator Jacob Taylor asked Council for some ideas on improvements for the interior and exterior of the City Hall building for 2019 budget. Councilman discussed putting together improvements and bidding out to contractors.

Council Reports and Comments

Alderman Lance Johns asked about paper that was in the packet. Nita Schroff, City Clerk, replied that a representative was asking for a refund on a late fee on their bill. Nita Schroff, City Clerk, explained that she refunded a late fee in December 2017, since they had never been late before and explained this would be the only time she would be refunding their late fee. They have been late 4 others times in the last 8 months.
